Online Applications are invited from eligible candidates for appearing in SAM Global University PhD entrance examination for admission to the below mentioned courses for the academic session 2021-22 (May 2022).

Candidates who have passed the qualifying examination in the relevant subjects with minimum 55% marks (50% marks for SC/ST/OBC) or equivalent grade are eligible to apply for SAM Global University PhD entrance examination. However, candidates appearing in the qualifying examination are also eligible to apply for the entrance examination, but he/she have to submit mark sheet of qualifying examination on or before the date of admission.

**Reservation:** As per M.P.Government Rules.

The syllabi prescribed for entrance examination are also available on the website. There shall be entrance examination and viva-voce for Ph.D. programme admission. NET, GATE qualified students shall be exempted from written examination.
